FORWARD AND SIDE TIPPING DUMPER

- All Plant is to be inspected prior to first use, by completing the appropriate prestart check sheet and daily / weekly recorded inspections thereafter
- Daily / weekly inspection records for site based plant are to be completed and displayed on the equipment if possible (using a Scafftag or similar system), or held by the work area
- Operators must complete a full induction prior to starting work and evidence of having signed on to the appropriate RAMS / WPP / TBS for the task provided
- Sites must assess the suitability and selection of dumpers for particular tasks and environments. A specific risk assessment must be completed prior to work commencing which can be detailed in the main works risk assessment. This must take account of the inclines and speeds at which they are to be used
